

INTRODUCTION

Our Story



The National Centre for Childhood Grief (NCCG) is dedicated to helping bereaved children rebuild their lives, by teaching them to live with their grief. The Centre was established in 1994 by founders Mal and Dianne McKissock OAM, internationally recognised experts in the field of child bereavement and grief counselling. Through their clinical practices, the McKissock's identified the profound impact bereavement has on a child's social, emotional, physical and cognitive development and the possible lifelong detrimental effects if the child doesn't receive appropriate support.

We are Australia's only provider of free and unlimited grief counselling for bereaved children aged 3 -18 years. The McKissock therapeutic model, developed and used at the Centre, represents best practice when working with bereaved people.

We operate from 'A Friend's Place', our dedicated bereavement care centre in Denistone East, Sydney. We offer a range of programs nationally, supporting children, families, adults and those who work with the bereaved. We have an experienced

team of specialist bereavement counsellors and trained volunteer support workers, led by our Clinical Director, Dr Elizabeth Mann, ensuring the effective delivery of our services.

One in 20 Australian children experience the death of one or both parents. We know this has a profound and lifelong impact on children. We know that our services contribute greatly to providing a child with the opportunity and resources to go on and live a full and meaningful life.

INTRODUCTION

Our Focus

Bereaved children often feel different and alone in their grief, leading to social withdrawal and isolation. They may find difficulty staying socially and academically engaged. It is common for bereaved children to experience anxiety due to the dramatically changed circumstances at home.

Bereavement counselling at our Centre has three important aspects:

- We **support** children to learn that the grief response they are experiencing is a normal reaction to death and that there are skills and techniques they can develop through this process to improve their wellbeing.
- We **teach** children to learn to manage intense feelings, build resilience and strengthen their confidence, as they integrate grief into their daily lives.
- We provide a safe, nurturing environment and community where bereaved children and families feel they belong, which supports them to not feel alone and different.

Our Programs

Through our programs, we provide a safe environment for bereaved children and their families to share their experiences, which in turn helps them integrate grief into their everyday lives.

Our care is delivered through the provision of the following programs:

- Individual counselling for bereaved children (free and unlimited), adults and caregivers (fee-for-service basis).
- Group support for bereaved children, bereaved parents and young adults.
- Weekend programs and workshops for bereaved children and families.
- Phone and email support for bereaved people and caregivers i.e. schools, hospitals and other healthcare professionals.
- Delivery of accredited bereavement counselling training programs.
- Publication and distribution of grief resources.
- National Outreach Support Service coordinated by Dianne McKissock OAM.

Clinical Director's Report



2019 marks the 25th Anniversary of 'A Friend's Place' and it seems fitting to pause and reflect on what has been, what is now and what is to come in the next 25 years.

Mal and Di then had the vision and the courage to set up the National Centre for Childhood Grief - the first specialised, free, children's bereavement service in Australia. Mal and Di deservedly both

received OAM's in 1996 in recognition of the incredible work they had done for the bereaved community over many years. Internationally recognised as leaders in this field, they have taught and advised thousands of health professionals around the world in the hope that bereaved children everywhere will have access to appropriate care.

Their vision and passion for helping bereaved children and their families has not diminished. The NCCG has supported thousands of bereaved families over the years and sadly, the need just keeps growing. The NCCG would not have survived and flourished without the support of many generous people. Mal and Di, our clinical team, administration staff and volunteers, our supporters, our board members, both past and present, and our clients, have all contributed to keeping 'A Friend's Place' going. I want to thank all of you for your wonderful support.

Over the past 25 years the NCCG has experienced many financial ups and downs. Running and funding a not-forprofit organisation certainly has many challenges, but the commitment of everyone involved at the Centre means that our vision has remained clear, no matter what hurdles we have to overcome. Our service is so important to families experiencing the pain of grief that we hold an unwavering belief that 'A Friend's Place' is worth fighting for. This financial year reaffirmed again the value and necessity of our services. 219 children accessed our bereavement counselling programs during this period, a 37% increase from the previous year. Our adventure

weekend programs for bereaved girls, boys and families were incredibly beneficial for all participants.

We facilitated an additional core education program in order to meet the increased demand for upskilling in this field and our National Outreach Service programs were also met with much appreciation and respect by those in need of our direct intervention support or our specialist training.

As people who are bereaved know all too well, grief makes life feel unstable and precarious and in this unchartered territory, the NCCG provides a necessary, secure anchor for so many people. Many years after the death of a loved person, children and adults who have used our service know they can come back if things get tough. Just knowing we will be here for them whenever they need help is an incredibly comforting thought for so many people. Our Young Adult

In 1994, 25 years ago, the Bereavement C.A.R.E. Centre gave birth to The National Centre for Childhood Grief — affectionately known for many as 'A Friend's Place'. Despite lack of funding, we were energised by hopes and dreams and a strong conviction that a specialist service for grieving children was a social necessity. We had established the Bereavement C.A.R.E. Centre 16 years earlier, and during the time we provided free care for grieving adults, it became clear that childrens' needs would remain largely overlooked or misunderstood unless a specialist service became their advocate. We had learned that people tended to believe children were resilient, would 'get over their grief', or that they didn't feel as intensely as adults. How wrong they proved to be.



A team of 20 part time counsellors, six board members, and an enthusiastic group of eight people who called themselves 'Friends of The Bereavement C.A.R.E. Centre', all volunteered their time to help us begin our journey into the future. The service was free, no counsellors were paid and the funds were not only tight but had to be shared with the Bereavement C.A.R.E. Centre which still provided free counselling for adults. A few years later, fees for adult counselling were reluctantly introduced as a matter of necessity. However, we remained

determined to ensure that children would be seen free of charge and the financial strain so often experienced by bereaved families would not be the reason a child could not be supported.

The Centre has always been proud of its greatest asset – people. First, the team of professionally competent counsellors and support workers who undertake intense, specialist training and clinical supervision to ensure that they provide the best service possible for bereaved children and their families. They model good




team work. Team work is essential – the exchange of ideas, shared skills, mutual support, good humour, compassion and adaptability, create an environment in which giving is as rewarding as receiving.

Next – the clients. The vulnerable people of all ages who have the courage to make that first phone call, the courage to walk through the door of an unfamiliar building and trust their vulnerability to the care of strangers, and finally, trust strangers with the care of their precious children. We are always sensitive to the leap of faith these steps require and work hard to deserve the trust placed in us.

Next – the supporters. As we celebrate our 25th anniversary, our silver anniversary, we want to express appreciation for all the people who have helped throughout those years: the initial Board led by Tom Wykoff; Patrons like Professor Beverley Raphael and Professor The Honourable Dame Marie Bashir AD CVO; Friends of The Bereavement C.A.R.E. Centre: wonderful folk like Rick Taylor who gave his heart and soul as Board Chair for so many years; past Boards comprised of women and men who were determined, supportive, and creative; the current Board of talented, compassionate human beings; past and current Office Managers, Counselling Coordinators and Business Development Managers who have kept the wheels turning in good times and tough; and all the folk who have contributed their time, energy and practical gifts. The first financial help the Centre received was from Barb and Don Spry who contributed what they called 'honey money' money from the sale of jam and honey at local stalls. Other folk - individuals and financial institutions - have made generous financial donations that have ensured the longevity of the service. Others have donated their creative ideas and enthusiasm. We are grateful for every contribution - no matter how big or how small – they were 'votes of confidence' that encouraged us all to keep going.

The NCCG was the first specialised service for bereaved children in Australia. Within Australia, we continue to be the leading experts on Childhood Grief and we are proud of the fact that in this safe setting, children's grief is normalised, understood, and supported as they learn how to live in a world that has been forever changed by their loss. If we could see into the future, we wonder what the NCCG might look like as it celebrates its 50th anniversary. We hope that there will always be those to help our successor, Dr Elizabeth Mann, to fulfil the dreams we began but are now hers, to ensure that all bereaved children can sustain the hope of a fulfilling future despite the pain of grief.

OPERATIONS

Our Bereavement Counselling Services

Individual Counselling

The NCCG has been providing individual face-to-face counselling to bereaved children and adults since 1994. To date our services have helped many thousands of bereaved children and their families.

In 2018-2019, there was a 41.5% increase in the number of counselling sessions provided from the previous year. Our profile raising over the past 2 years in corporate, community and media sectors has certainly contributed to this upsurge. Thankfully, we have had the capacity to meet this rise in service provision through the employment of an additional counsellor in January this year and the increase of availability within our existing cohort.

Email and Phone Support

All our counsellors are available to provide additional phone and email support to clients in between sessions if required. We also collaborate with multidisciplinary teams when necessary for transparency and alignment, to support children and families who are engaged in other systems of care. As part of our National Outreach Service, Dianne McKissock OAM, Cofounder and Patron of

the NCCG, provides email support for dying and bereaved people (all ages) and anyone involved in their care.

During the 2018-2019 period, we provided support and advice to more than 1,500 bereaved families and practitioners including hospital social workers, school counsellors and other health professionals.



Kids' Group

In addition to our individual counselling, we provide a Kids' Group program. As bereaved children often feel different and alone in their grief, some may benefit from processing their grief experience within a group environment, to know there are others who are in a similar situation. Taylah, who graduated during this period, shares her experience of being in group.



A KID'S GROUP TALE

Taylah's Story

"4 years!! That's how long I have been in the group at 'A Friend's Place'. I started group when I was only 8 years old. I'm not going to lie I was a bit nervous at first. But then I grew to realise that group was a nurturing and fun way to meet other kids that have been through something similar to your experience. You also get a new perspective on how you should handle situations at school, home, with friends and many more. Group has helped me through most of my primary

school years and I couldn't have asked for more nurturing, kind, funny and intelligent Counsellors. There was one thing that I realised on my final night in group, it was at the end of year party and I was dancing and singing with all my friends and looking around at all the happy faces and I realised that this right here was the definition of a community and a place where no matter what happened or who you were you will always be treated equally and have a strong sense of belonging in this group and at 'A Friend's Place' because everyone has had something bad happen to them but instead of bringing other people down they build each other up and at group they teach you that you are still allowed to live and laugh even if you've lost someone."

Parents' Support Group

The parent support group runs simultaneously alongside the kid's group. It is an opportunity for parents to connect and share with others who are experiencing similar challenges that inevitably come with grieving their own loss, while also parenting and managing the adjustment to the family system. Nikki (Taylah's Mum) shares her experience of being in this group.

My husband died nearly 5 years ago, my children were 6 and 8 years old. I felt alone and desperate, my life as I knew it was changed forever. I worried about my children, about life for them emotionallyhow will they do life with such a loss. My kids had no father! I then found 'A Friend's Place'. This has literally saved me and my children. Being part of this group has been incredible, to share experiences and struggles of life as a widow. Mal McKissock and the other Counsellors have been able to guide us through this journey that no wants to be part of. A huge thank you to all at 'A Friend's Place'. I feel confident that my children will be able to manage what life throws at them with all that they have learnt.

Young Adult Group

In April 2017, we introduced the monthly support group for young adults. This group is for young people aged 18 – 25 years, who were bereaved as children through the death of a parent/s and came to 'A Friend's Place' when they were children. This program identifies and explores the impact of childhood grief on early adult life, providing an opportunity for participants to learn a variety of strategies to navigate adulthood without the support and care of a parent/s.

Completion of the first year of this new program reaffirmed how valuable and necessary this service is for young people. The re-emerging nature of grief has meant for these adults they have needed extra support again while they transition through this life stage.

Participants have indicated after completing the first year that they are beginning to grasp how their childhood grief influences their perceptions and responses to daily life activities and interactions with family, friends, work etc. in ways that they could not recognise or did not originally associate to their grief before

attending the group. The participants have all expressed how helpful it has been to have a safe place where people understand their grief and how it is still affecting them. Overall, the group exceeded expectations.

Peter Coupland Adventure Programs for Bereaved Boys and Girls

This annual Adventure Weekend Program was established by and is named in memory of Peter Coupland, a valued and longtime counsellor at the Centre. These weekends are an important and special adjunct to our regular individual counselling programs. Currently, we run one girls and one boys adventure weekend each year. It is an opportunity for bereaved children to come together with others who understand this grief process. Through a combination of different adventure experiences, clinical group activities and discussion, having fun and relaxing together, the children find these weekends help them to feel less alone and different. Other benefits for children include increased levels of confidence and resilience and a greater capacity to talk about their experiences and feelings with family.

During this period, both weekends were again very successful with children thoroughly enjoying all aspects of the camp from the horse riding and pool time, to the grief focused clinical activities woven throughout

NEW PROGRAM

Peter Coupland Family Camp

While our counselling programs are designed to work with bereaved children, as a child's reaction to death is also dependent on the way that grief is demonstrated by caregivers and other adults, our support extends to include the parent/guardian and or caregivers. Our new program, the Peter Coupland Family Camp, where bereaved families come together in a group setting to work through the pain of their grief, was undertaken in May. This was incredibly beneficial for all the families who participated. By the end of the weekend there was an enhanced capacity to live with their grief in a meaningful way. Feedback indicated that one of the most significant aspects of the camp was the opportunity to meet with other bereaved families.

Clinical Supervision

Given the population we work with, the wellbeing of our staff is a high priority. All our counsellors must participate in both individual and group supervision each month. Extra supervision is always available for those who request it. Supervision is provided by Dianne McKissock OAM and Dr Elizabeth Mann, Clinical Director, both specialist bereavement counsellors and qualified clinical supervisors.

In-service Training

To ensure our counsellors meet their professional counselling bodies' annual requirements, we conduct internal professional development

training workshops. We seek to continue to diversify our in-service training with new topics and revisiting of significant areas to further instil these learnings.

In the 2018 - 2019 period, our special guest speaker was one of our counsellors, Manny Kassiotis, who recently began working with the NCCG, after finishing his work with the Missing Persons Unit. The Missing Persons Professional Development presentation provided an overview of the research, literature, and clinical interventions relating to the grief experience of families of missing people and ambiguous loss. This

is a particularly complex area, as there are often coronial proceedings, legal or financial issues, and media involvement. It provided our staff with a helpful insight into the complexities that come with this particular loss and what needs to be considered when working with people who are bereaved in this way.

Our counsellors were incredibly appreciative for this information. We see clients for all manners of death and while all will grieve 100% for the loved one who has died no matter the circumstances, ethically we need to remain well informed of any complex and high risk factors that can present with our clients and know how to best approach these situations.

Evaluation

We have many testimonials and feedback from our programs that indicate our services are valuable and helping bereaved people integrate grief into their daily lives.

Last financial year, with the support of our Board member, Dr Heidi Coupland, we developed a new evaluation program, which involves a formalised six month and 12 month follow up with the child's parent. While this project is still in its infancy, current findings from the first phase of our impact study during this period indicated that children/families benefitted from at

least 1 of the following three themes. The testimonials included are from parents [Names withheld].

 Emotional Catharsis: The emotional catharsis that happens at the Centre allows for children to return home more settled and with strategies to manage their grief, so it doesn't intrude on their daily life.

"Outbursts of emotion have lessened".

"Behaviour has definitely changed – more settled and sensory issues less notable and less disruptive".

2. Memory Consolidation: Literature consistently indicates that the observation of healthy grief does not resolve by detaching from the deceased but rather in creating a new relationship with them.

Remembering the loved one who has died is helping children integrate grief in a healthy way.

"Content knowing that her memory is being kept alive."

3. Peace of Mind: Coming here gave the surviving parent or caregiver peace of mind that their child was being taken care of in a specialised counselling environment. As such, reducing additional anxiety in the family system. "Provides comfort knowing kids are talking to trained professionals and are treated and cared for as a family unit."

"I am very concerned and worried about my children, so it helps me knowing that this is helping them."

2019 – 2020 Plans for Bereavement Counselling Services

Our second Peter Coupland family camp program is scheduled to run in May 2020. We will also seek to pilot a Young Adult weekend program.

As part of our National Outreach Services program, we have been invited to consult with the ABC producers on a new Playschool episode called 'Beginnings and Endings'. This is the first time in 54 years that Playschool has broached the subject of death in this way and we feel it is a really significant thing for them to do. We know that as a society, we still do not like to talk about death and grief, and any way we can encourage people to start to talk about it, will be of benefit to those children and families who are sadly living through the devastation of having a loved one die.

OPERATIONS

Our Education

The McKissock's are internationally renowned authorities on childhood bereavement with each having over 50 years clinical experience. During this time, the McKissock's have provided their specialised and accredited training programs throughout Australia and internationally. Mal and Dianne have acted as grief and bereavement consultants to a number of government departments and community organisations, including The Human Rights and Equal Opportunities Commission. In addition, Mal and Dianne have authored many books and articles for professional journals on grief, death, dying and bereavement. Through our programs we provide the opportunity for those working with bereaved people to upskill and gain competence and confidence in what is best practice. In doing so, we indirectly support many bereaved children and their families.



Professional Development Workshops

Currently we facilitate 3 accredited professional development training workshops in bereavement counselling at 'A Friend's Place'. Our Core Course in Bereavement Counselling, Working with Bereaved Children and Working with Bereaved Adults workshops, attract a diverse range of national and international participants, particularly those who are needing to upskill within this specialist area to further support their work (e.g. school

counsellors, teachers, psychologists, chaplains, police, social workers, funeral consultants and other health professionals).

During this period, we successfully introduced a second Core Course in Bereavement Counselling in response to the increased interest in training within this field. The feedback from all our workshops has been positive with high emphasis on the value and necessity of these skills to further enhance the participants' professions.

72% of participants noted that as a result of doing this course their understanding of grief had changed considerably. With all participants noting an increased confidence in working with bereaved people.

Post-Graduate Training

We also offer Post-Graduate Diplomas in working with bereaved adults and bereaved children for those wishing to become bereavement counsellors. As this is a specialist area, enrolment is by invitation only.

In 2018-2019 we enrolled one new children's counsellor who is set to graduate in December 2020. Our two counsellors who commenced training in the 2017 – 2018 period are well on track to complete their final assessments in December 2019, with graduation set for February 2020.

National Outreach Program Training

As part of the Centre's Outreach Program we provide tailored presentations and workshops to various organisations requesting resources and training.

During 2018 - 2019, we presented to Macquarie Group, Turks Legal, Merck, IPSHA Teachers Forum, Westmead Children's Hospital, Police Legacy, Northmead Uniting Church, Campbelltown School, Gosford High School, Notre Dame University and the Palliative Care Conference. Feedback from these sessions has been consistently positive with many participants expressing how valuable the information delivered was.





Schools received 'Grief Resource Packs'

Also, during this financial period, we were funded by Greater Charitable Foundation to distribute 'Grief Resource Packs' to 200 schools and facilitate a one-day intensive workshop on Children's Grief to 25 school counsellors within the Hunter/Newcastle region. We received consistent positive feedback from the schools for both the packs and the workshop. In particular, schools noted how helpful the packs are for all staff, not just counsellors.

Resources

The McKissock's have to date written and published 15 grief resources, accessible to both children and adults. Their book 'Coping with Grief' (currently in its fifth edition) has been an invaluable resource for many bereaved people since it was first published in 1988. Acknowledged by the ABC as the best selling book they have ever produced, it still remains after all this time our most popular purchase as well.

During this period, over 5,900 NCCG resources were purchased through 'A Friend's Place, a 70.7% increase from the previous year. This included Dianne McKissock's OAM new book titled, 'Coping with Grief after Suicide', written in response to the consistent demand for support regarding suicide related grief.

2019 - 2020 Education Calendar

All the education programs offered by the NCCG will continue to run in the 2019 – 2020 financial year. We have again scheduled 2 'Core Courses in Bereavement Counselling' to meet participant demand. In doing so, this also provides for an increase in education revenue to further support our financial sustainability. We also expect to commence training of another specialist bereavement counsellor to ensure future capacity to effectively and ethically deliver our programs.



Organisation Management

The NCCG is managed by our Clinical Director and Board Member, Dr Elizabeth Mann. Dr Mann is a qualified General Practitioner and specialist bereavement counsellor. Our Board is comprised of corporate business, legal, accounting, research and clinical professionals, who meet eight times each year. A finance subcommittee meets at regular intervals between Board meetings to refine, implement and evaluate the outcomes of our fundraising strategy.

Bereavement Counselling Faculty

The NCCG's current case load is managed by a team of specially trained bereavement counsellors. To specialise in this area and to work at the NCCG, all counsellors must have:

- A tertiary qualification in social work, counselling or psychology.
- Attended the NCCG's accredited training courses, including the 'Core Course in Bereavement Counselling', the 'Working with Bereaved Children' and/or 'Working with Bereaved Adults' programs.

- Graduated with an NCCG Post Graduate Diploma in Counselling Bereaved Children and/or Adults.
- Maintained a current 'Working with Children' check.
- · A current first aid certificate.
- Participated in monthly clinical supervision (individual and group) facilitated by Dianne McKissock OAM and Dr Elizabeth Mann.
- Participated in a minimum of 20 hours of professional development training annually.
- Undertaken child protection training

 In June, the Board approved the

 protection issues was also provided
 to staff when the new policies were

To develop and maintain a centre of Clinical Excellence to ensure that all bereaved children in NSW and eventually Australia, have access to appropriate support as they grieve, and to provide training and support for those who care for them.
